- ✓ Resolution 2872: Supplemental Budget for fiscal year 2022: *No public comments.*
- ✓ Resolution 2873 Adopting the 2022-2023 Budget: *The total budget at approved by the Budget Committee is \$112,659,185. Details about the budget are available at <https://pendleton.or.us/finance/page/city-pendleton-budgets>. No public comments.*
- ✓ Resolution 2987: State Revenue Sharing: *For FY22-23, State Revenue Sharing of \$200,000 is proposed as General Fund revenues for the support of public safety programs in the General Fund. State Revenue Sharing funds come from state taxes on the sale of liquor. No public comments.*

New Business:

- ✓ Amend Street Tree Ordinance 3366: *The Tree Commission recommended separating the "prohibited and discouraged tree" list from the ordinance so it can be easily updated by the Tree Commission. The list will be on the Parks & Recreation website.*
- ✓ Contract Extension for Transit Administrative Services : *Action extends the contract with GEODC from June 30, 2022 to June 30, 2023*
- ✓ Wastewater Facility construction grant consideration: *Kyle Willman spoke to council about authorizing a \$36,750 professional services agreement to AMERESCO to complete a grant application for a proposed solar panel array project at the wastewater treatment plant. Funds will be rolled into the project if the grant is successful*
- ✓ Development Agreement for Completion of SW Nye Ave: *City will loan funds to developer to extend SW Nye Avenue to Tutuilla Creek Road for the Pendleton Estates housing development.*
