Consent Agenda: *The consent agenda groups routine meeting actions into a single agenda item so they can be approved in one step, rather than in multiple motions.*

-  *Minutes of the Sept. 19, 2023; police officer residency request, STIF/STF Services Agreement with Umatilla County for transportation; purchase of a 2019 310SL backhoe for \$125,600; Resolution 2916 to accept a grant from DLCD to fund a consultant for the application of a 50-acre UGB expansion; Proclamation recognizing Indigenous People's Day.*

Public Hearings

-  Council Vote to continue Deliberations on Ordinance 4003, Making Municipal Court and Court of Record: *During a previous meeting, the discussion on Ordinance 4003 was tabled. This vote brings that item back into active discussion.*
-  Ordinance 4003, Relating to Municipal Court becoming a Court of Record: *Municipal Court Judge Blaine Clooten had recommended changing the municipal court to a Court of Record. At the September meeting, council voted to table this ordinance for additional research about potential costs and impacts. A work session took place Sept. 26.*
-  Ordinance 4004, Amending the Traffic Ordinance, 3238, as to Parking Provisions: *This ordinance changes the limit for parking in a public place to 48 hours and adds prohibitions against sleeping and living in vehicles except for what is allowed by the resting ordinance. It also reduces the "posting" time period, or the time between police tagging a vehicle and when it can be towed, to 72 hours. During the public hearing, James Preston and Lynette Preston spoke about concerns the ordinance would lead to homeowners having vehicles towed.*

New Business



Council Report on Parks Grants: Pendleton Parks and Recreation Director Liam Hughes updated the council on three grants the department has received: \$220,000 for two years of operations of the Afterschool Program; \$340,000 to renovate and rebuild portions of Roy Raley Park, focused on the former Natatorium facility, \$2 million to create a Pendleton Urban Forestry Program to reinforce resilient green spaces and increase access to the outdoors.



Bus Barn Transit Facility: CMGC Services: Guaranteed Maximum Price (GMP) Amendment 1: *This amendment authorizes up to \$316,500 for heating, ventilation, and air conditioning (HVAC), electrical, communications, and electronic safety at the Bus Barn Facility. The entire facility project has a budget of just over \$3 million, and the funding in this amendment is built into that amount. A second amendment for the remaining construction project items is expected at the Nov. 7 meeting.*

Bids



River Intake Bid Award: *Staff recommended City Council award purchase of the River Intake Pumping System Upgrade to Layne of Washington in the amount of \$62,500. These upgrades are part of a larger process to increase the amount of filtered water the Aquifer Storage & Recovery (ASR) Program can store each year by 300 million gallons.*
